Any portion of the costs not covered, will be the responsibility of the customer. It is the discretion of Havlin's Firearms Finishing the selling price of the firearms. There is a 90 day guarantee on labor from the date of completion. If the same problem arises in the 90 day period, additional labor to that specific problem will be at no cost to the customer. Aftermarket parts will not be subject to guarantee. Guarantees DO NOT cover neglect, misuse, abuse, or supernatural acts. Any new work or operational problems will be billed accordingly.

I understand that if I do not choose to request a written estimate, I shall be liable for any and all parts and labor charges for the work completed on my firearm.
